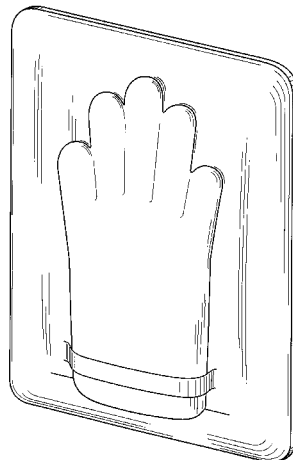
(57) **CLAIM**

The new design for a portable device holder with a hand compartment, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear isometric view of a portable device holder with a hand compartment;  
FIG. 2 is a rear isometric view of the portable device holder in use, wherein an environmental broken line depiction of an electronic device and hand are shown inserted in the device holder;  
FIG. 3 is a front perspective view of the device holder wherein an environmental broken line depiction of an electronic device is shown accommodated in the holder;  
FIG. 4 is a rear orthogonal view thereof;  
FIG. 5 is a side orthogonal view thereof;  
FIG. 6 is an opposite side orthogonal view thereof;  
FIG. 7 is a top orthogonal view thereof; and,  
FIG. 8 is a bottom orthogonal view thereof.  
The broken lines shown in the drawing figures are not claimed.

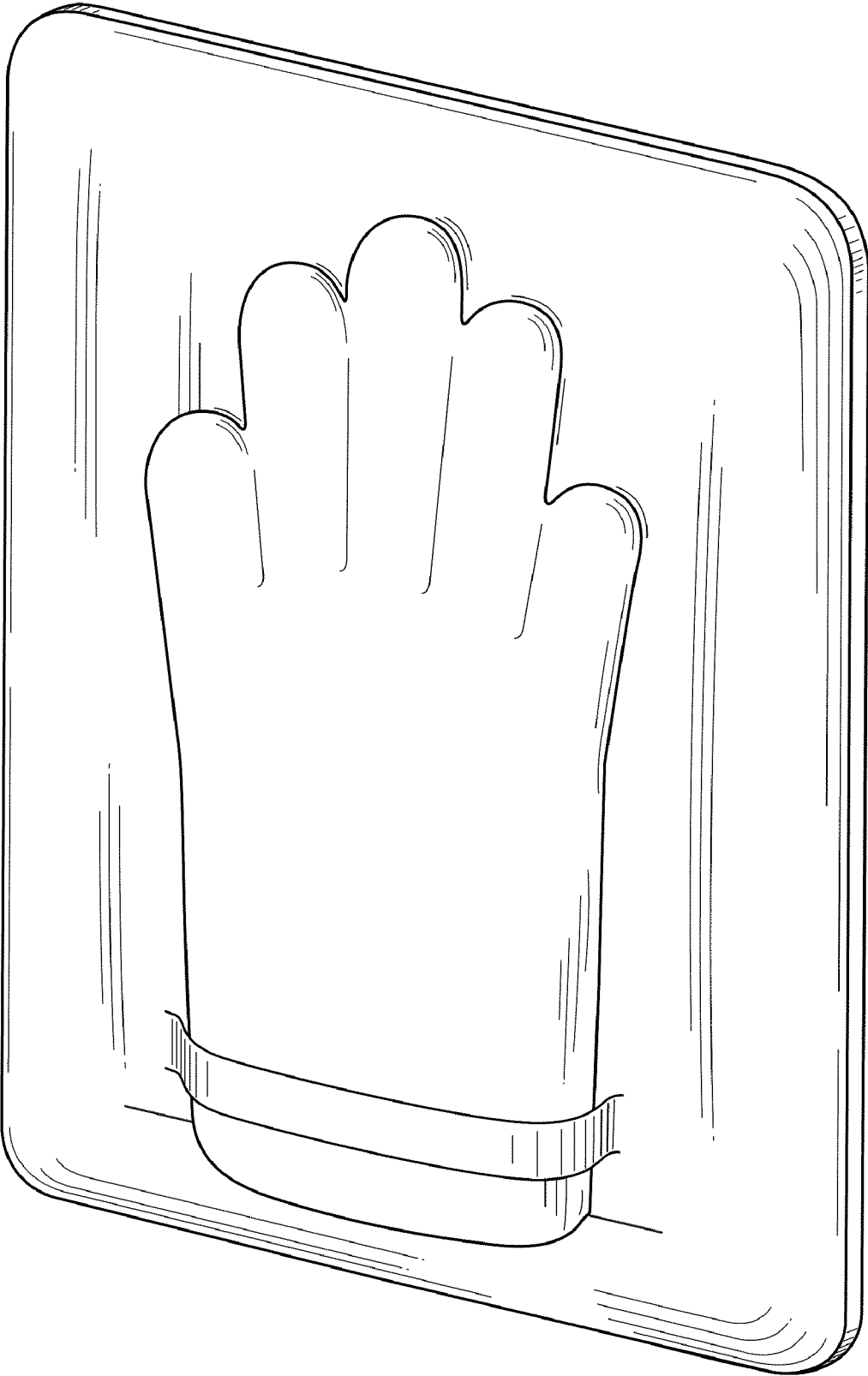

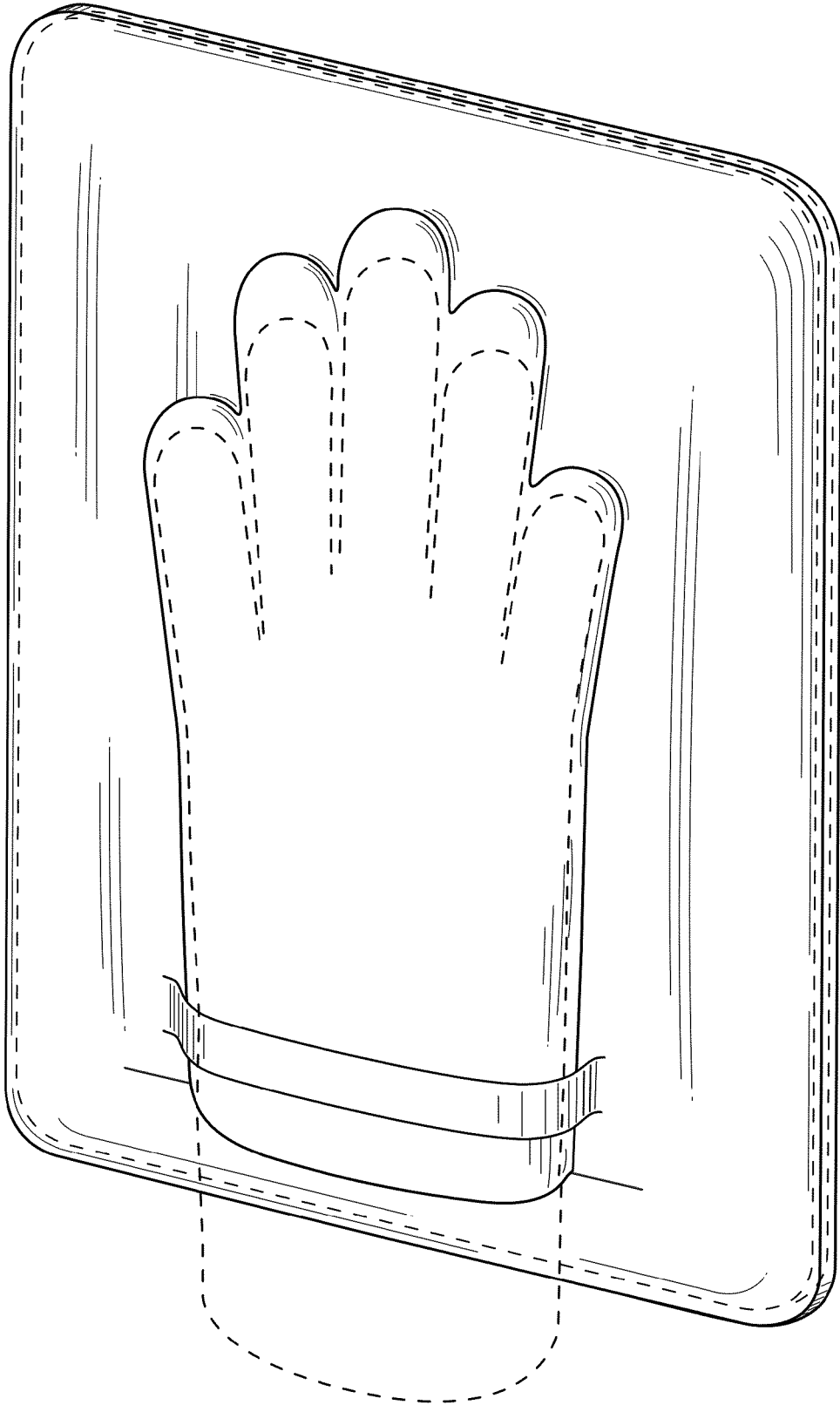

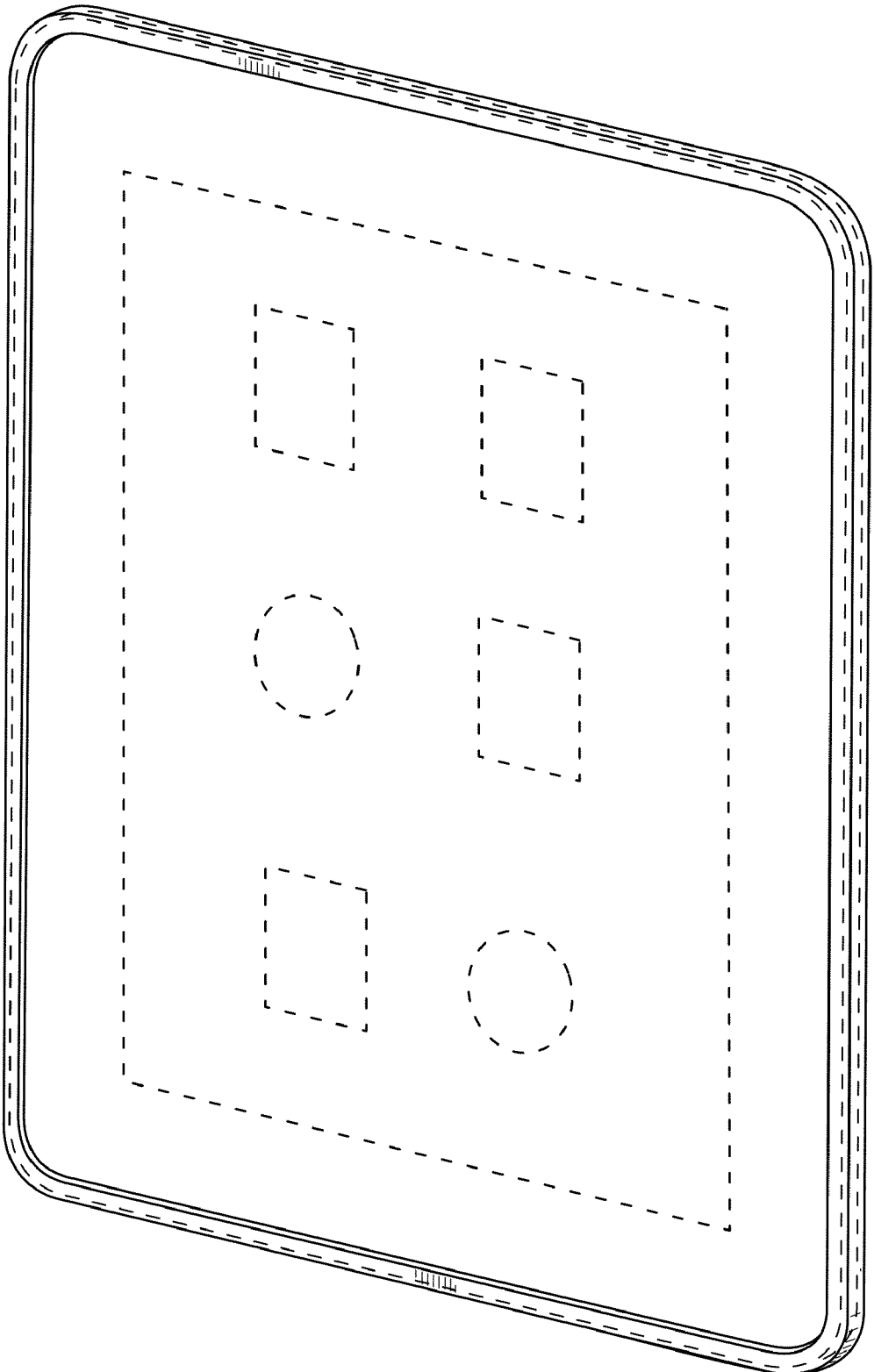

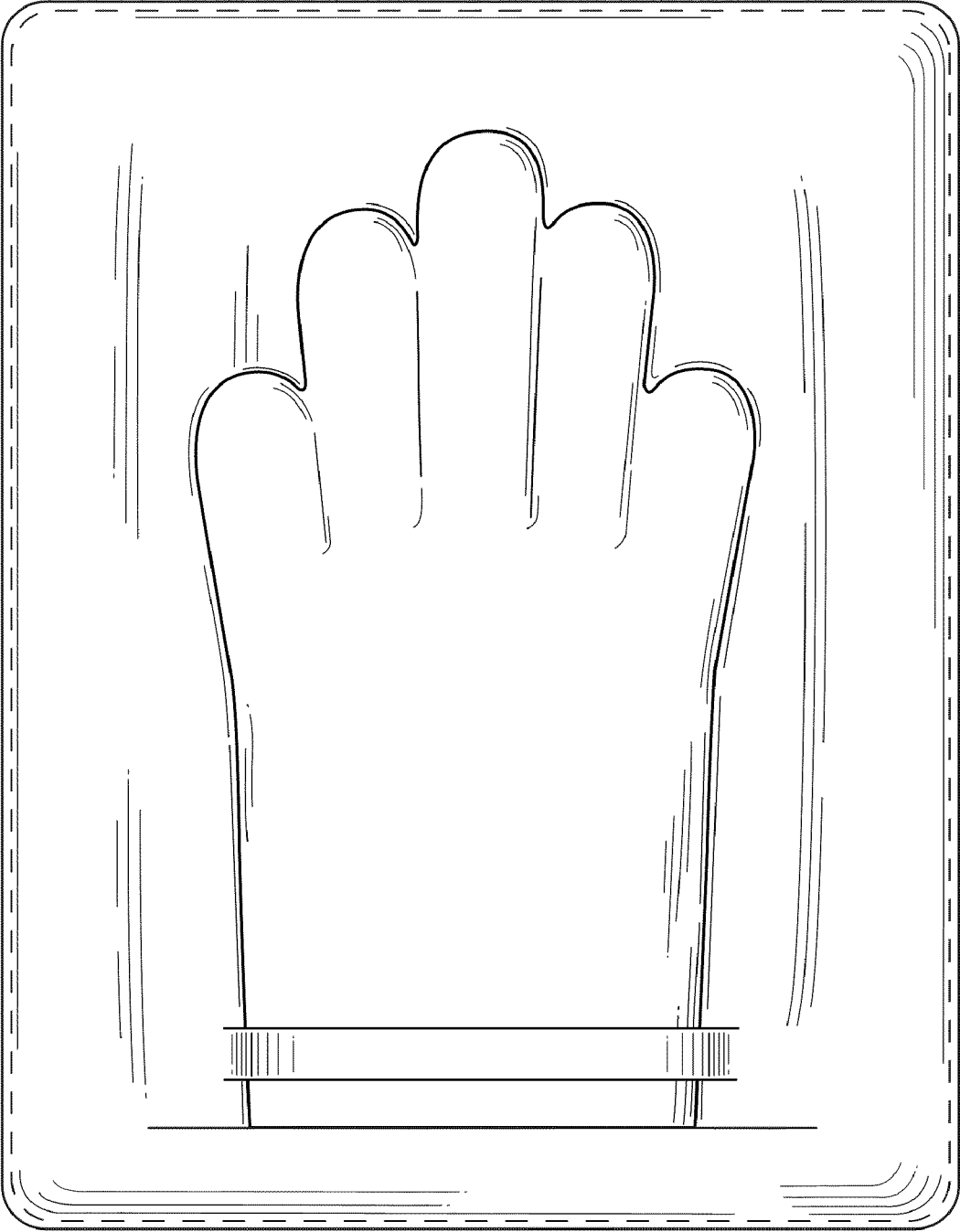

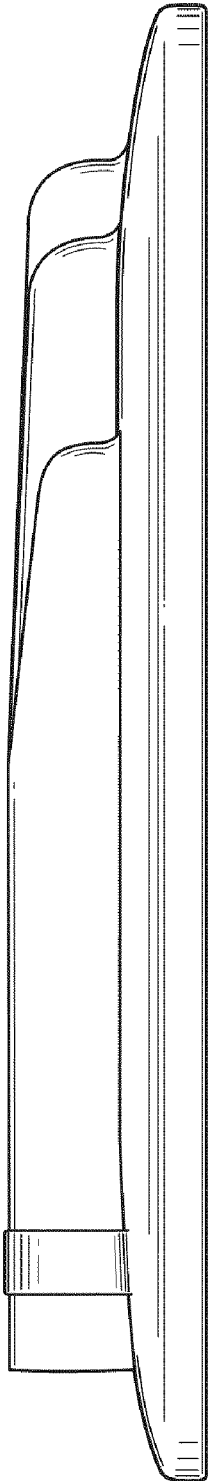

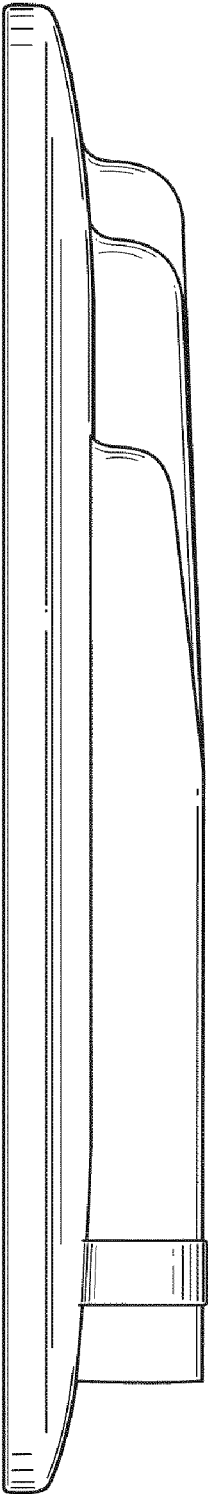

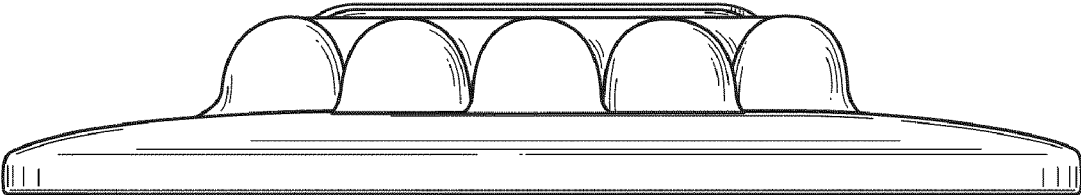

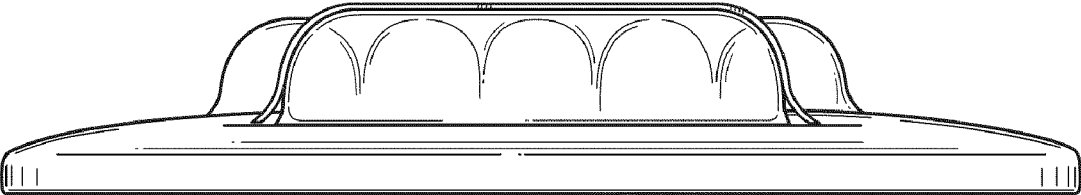
