THE MARK CONSISTS OF A RECTANGULAR DESIGN WITH A LIGHT BLUE BORDER. AT THE TOP OF THE RECTANGULAR DESIGN ARE THE NAVY BLUE, STYLIZED WORDS "TRANQUIL TRANSITIONS, LLC," WHICH APPEAR WITHIN A BLACK OUTLINE SHAPED LIKE TWO HOUSES.
