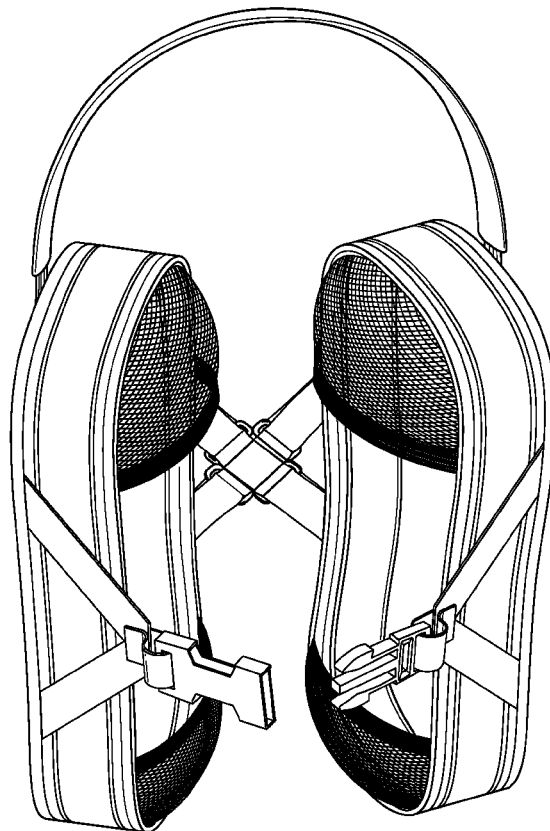
(57) **CLAIM**

The ornamental design for a footwear carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a footwear carrier showing our new design;
FIG. 2 is a rear perspective view thereof.
FIG. 3 is a top perspective view thereof.
FIG. 4 is a front perspective view thereof, showing footwear accommodated within the opposing pouches; and,
FIG. 5 is a side perspective view thereof, in a closed position.
The broken line showing of footwear in FIGS. 4-5 is for the purpose of illustrating environment and forms no part of the claimed design.

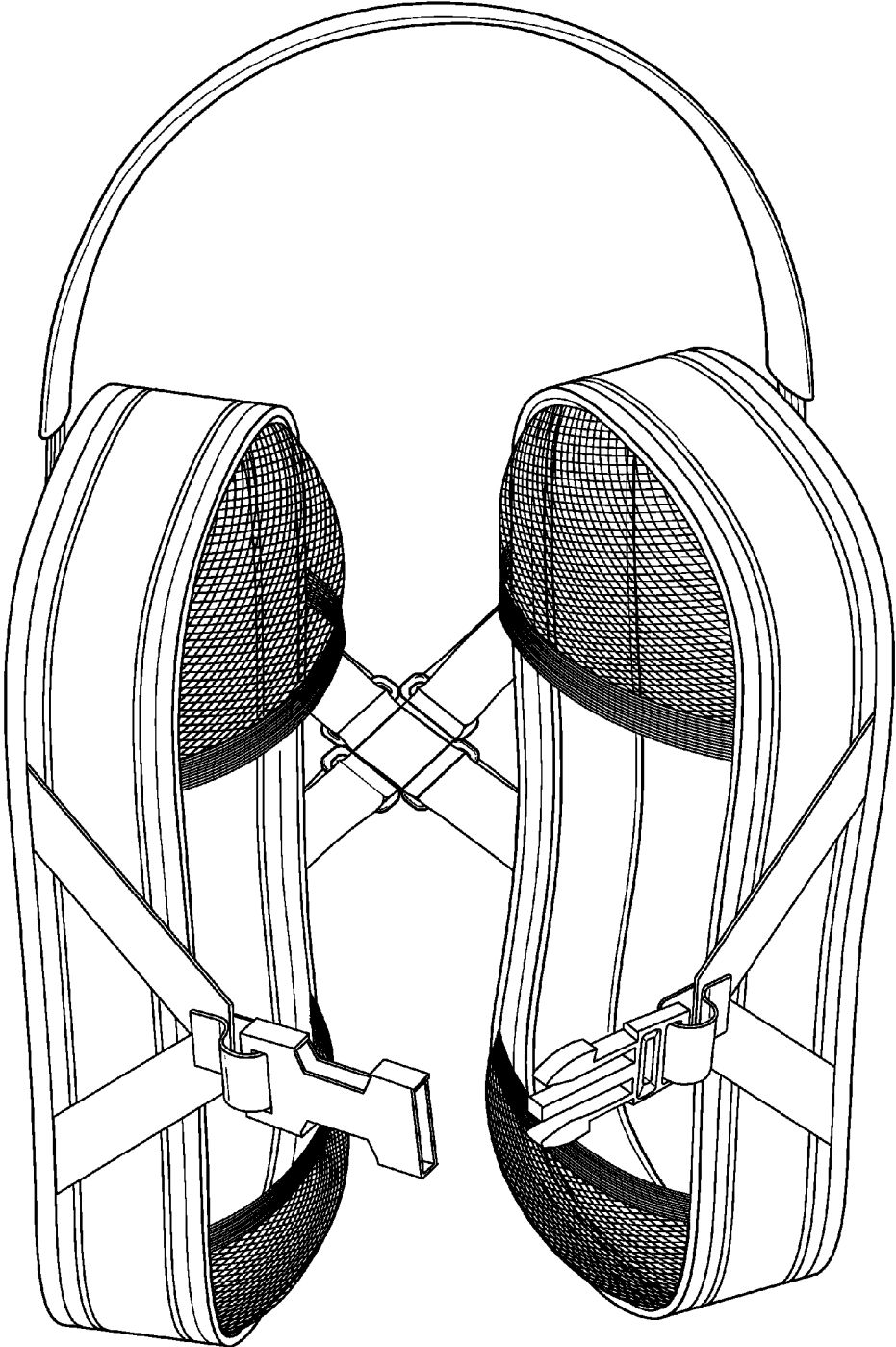

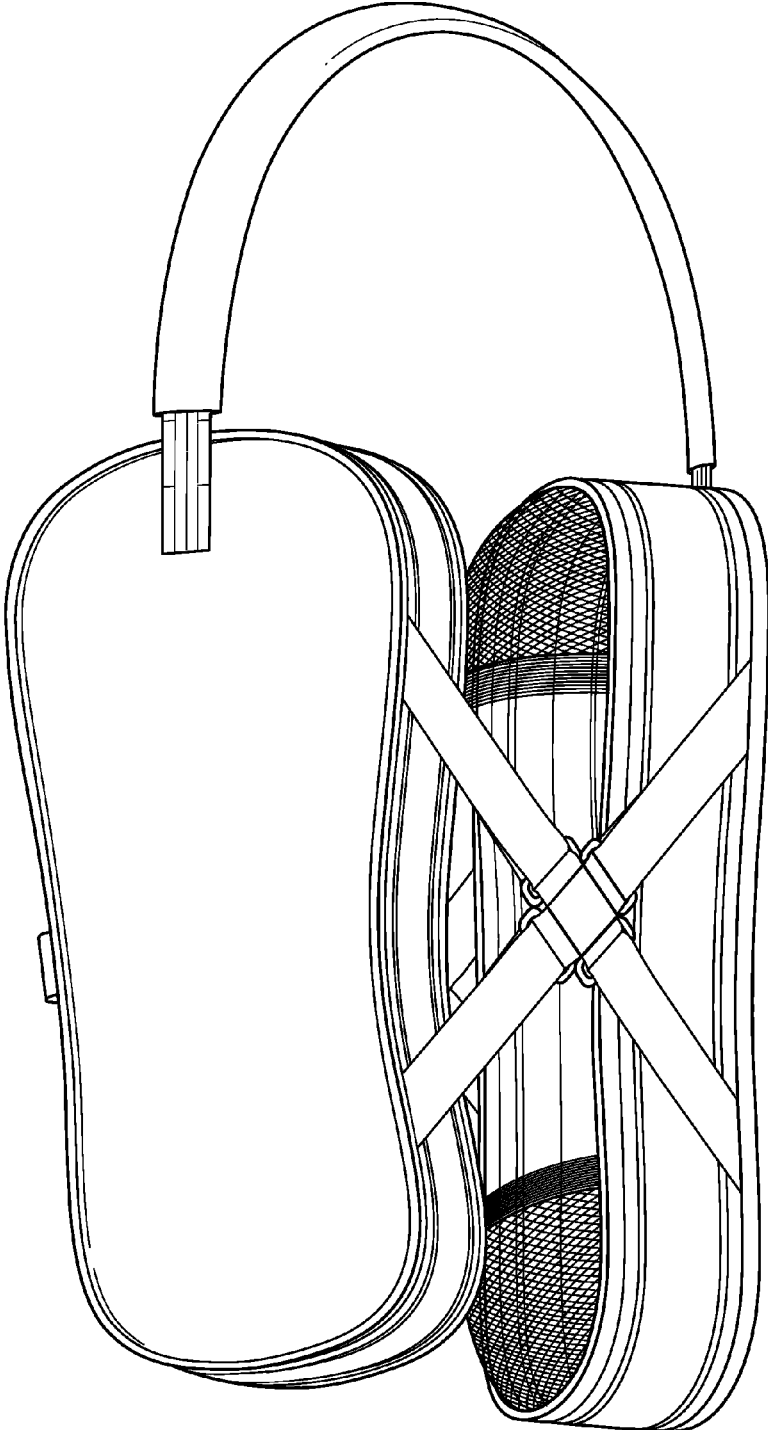

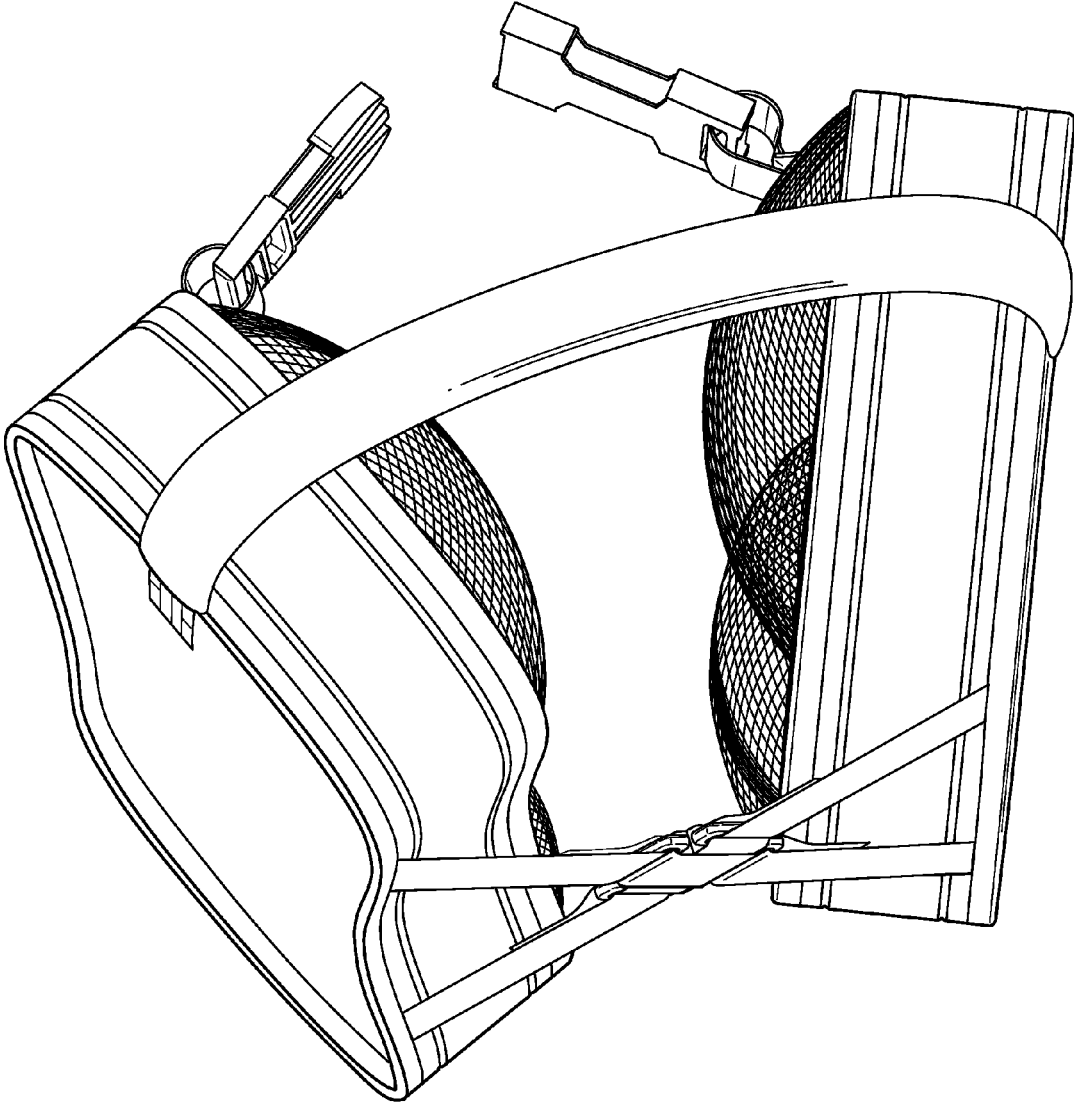

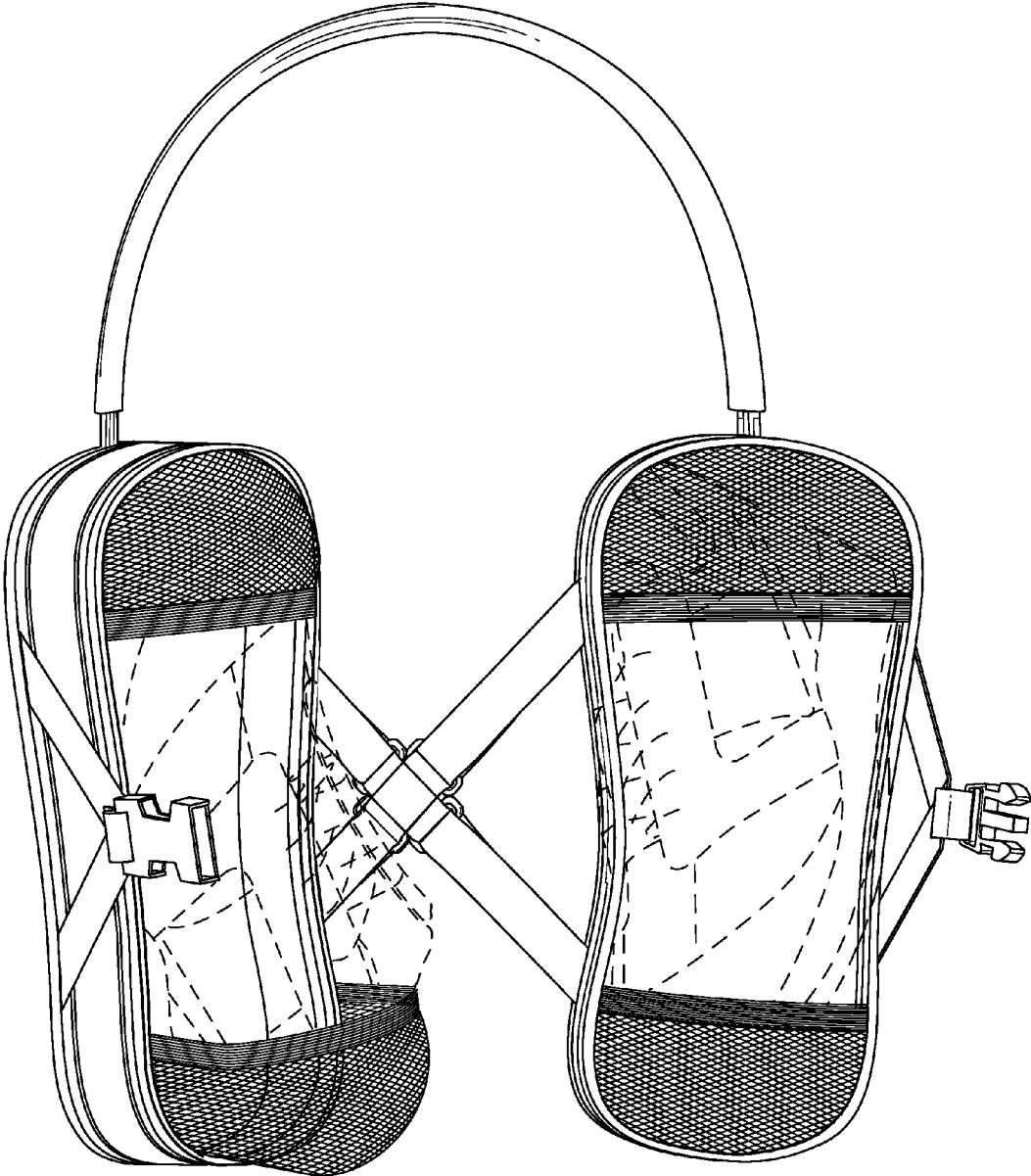

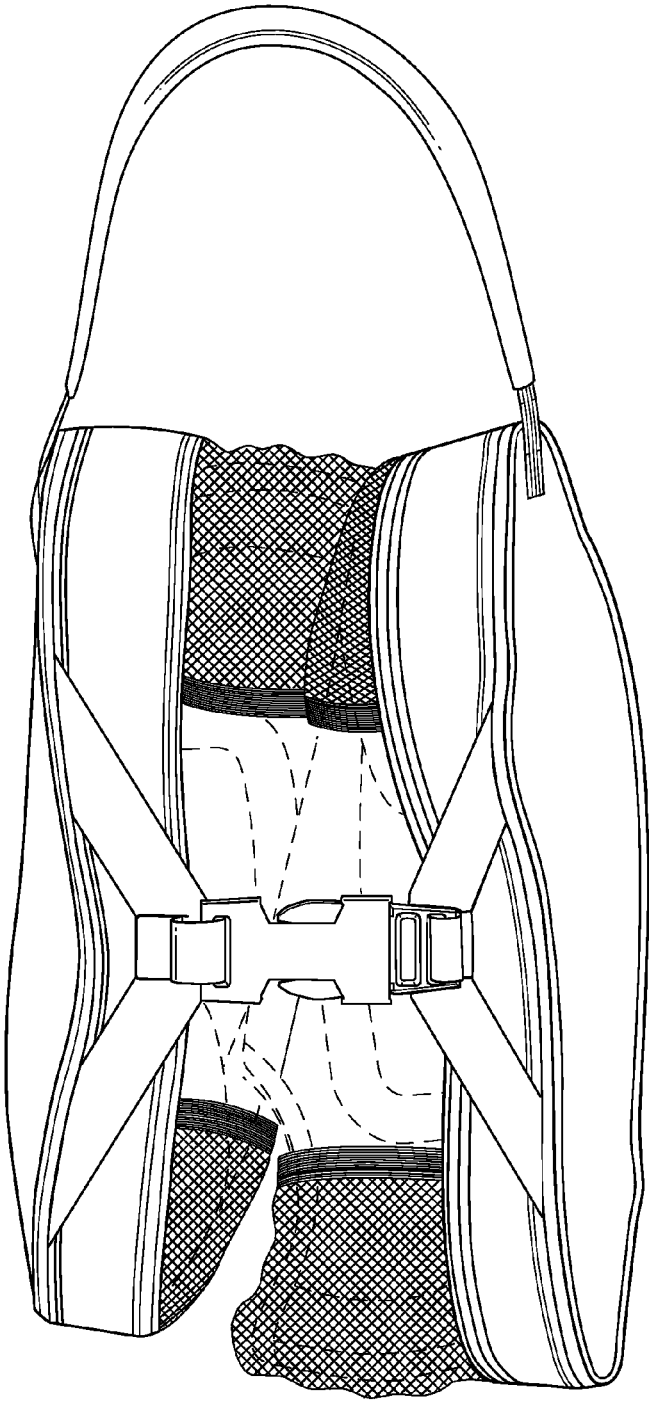
